They also get birthday or anniversary greetings, announcements of the birth of babies, and the engagements of friends and loved ones. Those who live in some of the Villages or the Bush with no communication welcome this program as it comes in very handy.

## **Trapline Chatter Acceptance Requirements:**

Messages need to be called in to (907) 488-2216 Messages can be given to the receptionist or left on the voice mail/answering machine. Messages need to be received by 8:00 pm Alaska Time to be aired that day. Messages should be limited to approximately 1 minutes in length. Messages need to contain all required information for us to air them. (required information is listed below)

KJNP is not responsible for the content or length of any message, and KJNP reserves the right to reject any message that can be transmitted by any other means of communication.

## Trapline Chatter Message Information needed:

- Who we are sending it to.
  - First and Last Name of one recipient.
  - Part of the name does not need to be broadcast if that is noted.
- Location it is going to.
  - Cannot be in a phone service area.
- Who it is coming from.
  - First and Last Name of one sender.
  - $\circ$   $\,$  Part of the name does not need to be broadcast if that is noted.
  - Phone number where we can contact you if there are questions regarding the message
  - Phone number does not need to be broadcast if that is noted.
- Location it is coming from.
  - City and State.
- Message contents.
  - Can not be a coded message.
  - $\circ~$  Can not be offensive to broadcasting.
  - We need to know the general contents of any packages mentioned.
    - This is required for our legal protection and records. and does not need to be broadcast if it is noted.
  - No death notifications unless the immediate family already knows.
    - This must be confirmed and noted.
  - If asking for the recipient to return a phone call
    - We need an explanation of this for our records
      - To ensure that the recipient does not live within a phone service area,
      - The general reason for the call for our legal protection.
      - This does not need to be broadcast if noted
  - $\circ$   $\,$  Any other information to understand the message and have complete records.
    - If something does not fit with these requirements, you will need to speak with a receptionist to see what other options there may be.
