Those who use this program call KJNP at 907-488-2216 to send messages that may contain a greeting or letting them know that they are sending mail or boxes their way and to be looking for them. They also get birthday or anniversary greetings, announcements of the birth of babies, and the engagements of friends and loved ones. Those who live in some of the Villages or the Bush with no communication welcome this program as it comes in very handy.

## Trapline Chatter Message Information needed:

- Who we are sending it to.
  - Full name of one recipient for our records.
  - Full name does not need to be broadcast.
- Location it is going to.
  - Cannot be in a phone service area.
- Who it is coming from.
  - Full name of one sender for our records.
  - Full name does not need to be broadcast.
  - Phone number of who it is coming from.
  - Phone number does not need to be broadcast.
- Location it is coming from.
  - o City and state.
- Message contents.
  - Can not be a coded message.
  - Can not be offensive to broadcasting.
  - We need to know the contents of any packages mentioned.
    - This is for our records and our protection, and does not need to be broadcast.
  - No death notifications unless the immediate family already knows.
  - If asking for the recipient to return a phone call
    - We need an explanation of this for our records
      - to ensure that the recipient does not live within a phone service area,
      - the reason for the call for our protection.
    - This does not need to be broadcast.
